Academic assignments

I have broad experience of Academic teaching (also interdisciplinary), refereeing, evaluations, committees and so on. Between 1 Jan. 2009 and 31 Dec. 2010 I was chair of the Unit for Technology and Social Change, Linköping University. Between 2005-2011 I was Chair of the Swedish National Committee for History of Science and Technology. 2005-2016 I sat on the board of Uppsala University's Centre for Science and Technology Studies (Chair of the board from Oct. 2014) and since 2006 on the Advisory Board of the Centre for History of Science at the Swedish Royal Academy of Sciences. From 2011 to 2016 I was Chair of the Swedish History of Science Society. Since January 2012 I am a Fellow of the Swedish Royal Academy of Sciences. I am a fellow of three other royal academies in Uppsala. Since 2015 I am a member of the Board of Uppsala University; I was recently elected for another 3-year period. 2001-2006 I was editor of *Lychnos*, the Swedish yearbook for history of science and ideas.

Research

My main line of work has been in the history of science from the 18th century onwards. I have published on the history of astronomy, geodesy, cartography, experimental physics, genetics, biochemistry and high-energy physics. I have mostly focussed on cultural and political aspects of science but have also written on more technical as well as economic aspects and on research policy. Currently I lead a research project financed by the Marianne and Marcus Wallenberg Foundation. The project, "Brown networks" concerns intellectual connections between Sweden and Nazi Germany, especially among Swedes sympathetic to the Hitler regime. I also participate in a project, financed by the same foundation, on the history of the Royal Swedish Academy of Sciences: Science and Modernization in Sweden.
